The Fire Hall currently includes kitchen facilities, restrooms, ice machine, tables and chairs. A \$400.00 **Security Deposit** will be required to reserve all rentals. It will be refunded upon a satisfactory inspection of the building after the event.

**No confetti of any kind or glitter allowed.** Fun Tack is to be used to hang decorations and must be removed from walls and other surfaces. No tape is to be used on walls, doors, windows or light fixtures. Failure to comply will result in forfeiture of the full Security Deposit.

The newly renovated Fire Hall can comfortably accommodate 120 people for a sit down dinner. Hall rental is available for all your Party Needs, Bridal and Baby Showers, Birthday Parties, Communions, Graduations, Small Weddings, Anniversaries.

### **CONTRACT POLICIES:**

1. Payment balance, rental times and cancellations **MUST** be made **TWO WEEKS** prior to date reserved. Cancellation's later than that will result in forfeiture of security deposit.
2. Renters must be 21 yrs. of age. If you wish to sell alcohol, indicate on the application so that Fire Company approval can be ascertained.
3. You must supply your own cooking/eating utensils, dish soap/cloths and towels.
4. Facility is to be left broom clean and vacuumed. Sink, stove and refrigerator should be cleaned if used. Wipe down, fold and return tables and chairs to the position they were in upon arrival. All trash must be taken out to the dumpster. Pick-up in the rest room areas. Sweep floor. Hallway, steps, lobby and outside area must be cleaned and swept. All cigarette butts left outside, cups, bottles and cans, etc. must be disposed of properly. Failure to comply will result in the forfeiture of the Security Deposit.
5. **NO SMOKING ALLOWED.**
6. The Clubroom is off limits.
